### **Summary of Motions:**

- Approved Resolution 2023-01 to support 2022-2025 Safety Pavement and Bridge (PM2) and System Performance (PM3) Performance Targets by TDOT.

<u>Call to Order</u>: Meeting called to order at 11:05 a.m. by the Chairman, Mr. Randy Trivette, standing in for the Honorable Mayor Dr. Todd Fowler.

**Agenda Item 1**: Mr. Trivette introduced Butch Eley, the Deputy Governor for Tennessee and the Commissioner of the Tennessee Department of Transportation.

Mr. Eley presented on the new "Build With Us" initiative that introduces the Transportation MTPO Modernization Act. This presentation is available on the website https://jcmpo.org/minutes/2023/Build%20With%20Us.pdf. Commissioner Eley also showed a video explaining more about Choice Lanes - https://youtu.be/mjydhb5ogzs. In summary, TDOT is proposing to partner with the private sector to build new lanes on congested, urban highways. This will free up state funds for more projects in rural communities. TDOT is also alternative project delivery tools to speed up the process to get projects to construction. Also, TDOT is proposing an increase in the electric vehicle registration fee.

Several members asked Deputy Governor Eley questions regarding the proposal. The Honorable Alderman Kelly Wolfe showed support for the creative use of alternatives to funding and more support for rural areas. The Honorable Mayor Chuck Vest is looking forward to the accelerated project delivery, as Jonesborough is currently waiting on the installation of an important traffic signal. Honorable Representative Tim Hicks stated that he and his colleagues are generally favorable towards the proposal and he feels it is a good plan.

Chairman Mr. Trivette thanked the TDOT staff for coming and presenting to the Executive Board.

**Agenda Item 2:** Chairman Mr. Trivette asked if there was any input from the public. There were no comments from the public.

**Agenda Item 3**: Chairman Mr. Trivette moved to Item 2, to approve the minutes from the December 13, 2022 meeting.

Ms. Ronda Sawyer made a motion for the board to approve the minutes of the December 13, 2022 meeting. The Honorable Mayor Chuck Vest seconded the motion.

All approved. Motion carried.

<u>Agenda Item 4</u>: Chairman Mr. Trivette moved to Item 4, to consider approval of a resolution to support 2022-2025 Safety Pavement and Bridge (PM2) and System Performance (PM3) Performance Targets by TDOT.

Mr. Berry explained that the Johnson City MTPO staff recommends that the Executive Board continue to support the state's targets for PM2 and PM3. All of the interstates and highways on the National Highway System are owned and maintained by TDOT. He explained the pavement and bridge condition (PM2) targets that TDOT has set for the state. A handout was provided showing the pavement conditions for the Johnson City MTPO area. Only 0.6 percent of the pavement for state routes are in poor condition. Also provided in a handout was a list of the state-owned bridges in poor condition. Within the Johnson City MTPO area, there are four bridges in poor condition.

Mr. Berry also went over the system performance (PM3) targets, which cover interstate and highway

reliability and also freight reliability. Reliability compares the average travel time (50<sup>th</sup> percentile) to the 80<sup>th</sup> percentile and then expressed as a percent of the person-miles traveled. Two of the state's targets are related to areas with air quality issues, which only apply to Memphis and Knoxville.

The Honorable Mayor Jeff Broyles made a motion for the board to approve the resolution to support 2022-2025 Safety Pavement and Bridge (PM2) and System Performance (PM3) Performance Targets by TDOT. Mr. Johnny Deakins seconded the motion.

All approved. Motion carried.

<u>Agenda Item 5</u>: Chairman Mr. Trivette moved to Item 5, an update on U.S. Census Bureau's 2020 Urban Areas. This was an informational item.

Mr. Berry presented a map showing the new 2020 Johnson City Urban Area. The Census Bureau did not combine any of the urban areas in Northeast Tennessee. The boundary was retracted a little bit, reducing the square miles by 3.91 miles; however, we gained 8,104 in population. Mr. Berry then displayed a series of maps that showed the Johnson City Urban Area during each decennial census since 1990. The area has mostly grown denser rather than expanded. Ms. Sawyer asked if the town of Watauga was still a part of the Johnson City Urban Area and Mr. Berry said no, it was no longer included within the boundary.

Mr. Berry said the next steps for the MTPO staff is to observe the boundaries and adjust them. The Census Bureau drew lines down the middle of roads, so it makes sense to adjust the boundaries and "smooth" them out to take in the whole road. This process will take place over the next several months and will need to include a review of the Functional Classification System, which makes roads eligible for federal funding depending on their classification.

Chairman Mr. Trivette asked if the boundaries will be set for the next 10 years. Mr. Berry said it should; however, because of the way the Census Bureau used households instead of population to define the boundaries, they could choose to come back and update them at a later date. If they do that, it will be announced in the Federal Register.

Ms. Logan Engle asked if projects located outside the new boundaries are still eligible for funding. Mr. Berry said that we will finish currently planned projects but no new projects would be eligible.

**Agenda Item 6**: Chairman Mr. Trivette moved to Item 6, Other Business.

Mr. Sean Santalla introduced himself as the new team leader for Program Development for the Tennessee Division of FHWA. He introduced Mr. Zach Coleman as the new planner that will cover our region. Mr. Gilberto DeLeon, Deputy Division Administrator, also announced that the RAISE grant is accepting applications until February 28, 2023. Mr. DeLeon also mentioned U.S. DOT has launched a new website to assist communities with grants from U.S. DOT called the "DOT Navigator," and can be found at <a href="https://www.transportation.gov/dot-navigator">https://www.transportation.gov/dot-navigator</a>.

Mr. Stacy Morrison introduced himself as the Planning Manager for TDOT's Office of Community Transportation. He announced that they will be accepting applications soon for the Transportation Planning Grant. More information can be found at this link - https://www.tn.gov/tdot/long-range-



### Resolution 2023-02: Consider approval of adopting the Fiscal Years 2024-2025 Unified Planning Work Program

The Johnson City MTPO staff has finalized the Fiscal Years (FYs) 2024-2025 Unified Planning Work Program (UPWP) for Executive Board approval. The UPWP outlines tasks to be undertaken by the Johnson City MTPO, along with identifying funding sources to complete these tasks. The two-year UPWP covers the federal fiscal year starting on October 1, 2023 and ending on September 30, 2025.

The UPWP covers five traditional tasks that are included every year. Major tasks include finalizing the urban area and planning boundaries, addressing new federal emphasis areas, and implementation of the Bipartisan Infrastructure Law (BIL). A new 2026-2029 Transportation Improvement Program will also be drafted in order for it to be adopted by the end of calendar year 2025.

The draft UPWP was submitted to the Tennessee Department of Transportation, Federal Highway Administration, and Federal Transit Administration for their review and comment. During this review process, comments on the draft were provided to the MTPO from these agencies and satisfactorily addressed.

Resolution 2023-04: Consider approval of a resolution to amend the Fiscal Years 2023-2026

Transportation Improvement Program (TIP) to add funding in Fiscal Year 2023 for the Traffic Signal for SR 34 (US 11E/E Jackson Blvd) & Tiger Way, along with revising the scope to add the installation of turn lanes

Jonesborough has requested an amendment to make changes to TIP Project 2017-16, the Traffic Signal for SR 34 (US 11E/E Jackson Blvd) & Tiger Way. This intersection is being improved to more efficiently and safely handle traffic to the new Jonesborough Elementary School (K-8) with a capacity for 1,100 students. An additional \$50,000 of 100% federal funding for construction is needed for the traffic signal portion of the project. The scope will also need to be changed, as the extension of turn lanes on 11E and installation of turn lanes on Tiger Way is necessary to add storage capacity for the anticipated queue of traffic. An additional \$200,000 (\$160,000 federal and \$40,000 local) is needed to fund the additional scope, which will require a 20% local match. In addition to extra funding for construction, the project will also need an additional \$15,600 for the NEPA phase and \$18,000 for the Design phase.

### Below is a summary of the changes:

PE-NEPA: From \$9,400 to \$25,000
 PE-Design: From \$25,000 to \$43,000
 ROW: \$15,000 (Will remain the same)

CONST (Traffic Signal): From \$350,000 to \$400,000CONST (Turn Lanes): \$200,000 (new funding)

• Total: From \$415,000 to \$698,600

### RESOLUTION OF THE EXECUTIVE BOARD OF THE JOHNSON CITY METROPOLITAN TRANSPORTATION PLANNING ORGANIZATION (MTPO)

To Amend the Fiscal Years 2023-2026 Transportation Improvement Program (TIP) to add funding in Fiscal Year 2023 for the Traffic Signal for SR 34 (US 11E/E Jackson Blvd) & Tiger Way project, along with revising the scope to add the installation of turn lanes

**WHEREAS,** Johnson City Metropolitan Transportation Planning Organization (MTPO) is responsible for programming of funds for Transportation Purposes; and

**WHEREAS,** it is the responsibility of the Johnson City MTPO to program these funds for transportation projects in the Transportation Improvement Program (TIP); and

WHEREAS, the Town of Jonesborough is building a new K-8 elementary school with a capacity for 1,100 students, with Tiger Way being the main route to the school from SR 34 (US 11E/E Jackson Blvd); and

WHEREAS, due to safety concerns, a traffic signal is being installed at this intersection and requires additional funding of \$68,000 (100% Federal) for Preliminary Engineering and Construction phases; and

**WHEREAS**, during design, it became necessary to add to the scope of the project by adding the installation of turn lanes for additional storage of queued vehicles and require additional funding of \$200,000 (\$160,000 Federal and \$40,000 local); and

**NOW, THEREFORE, BE IT RESOLVED** that the Executive Board of the Johnson City Metropolitan Transportation Planning Organization does hereby amend the Fiscal Years 2023 – 2026 Transportation Improvement Program to add funding in Fiscal Year 2023 for the Traffic Signal for SR 34 (US 11E/E Jackson Blvd) & Tiger Way project, along with revising the scope to add the installation of turn lanes.
