**<u>Call to Order</u>**: Meeting called to order at 11:13 a.m. by the Chair, the Honorable Mayor Jenny Brock.

<u>Agenda Item 1</u>: Chair Mayor Brock asked for introductions from those present in the back of the room. Mr. Glenn Berry proceeded to ask if there were any comments from the public. Ms. Ashely Davies with the Tennessee Department of Health announced there was a new grant opportunity for Healthy Communities available and to contact if interested.

Agenda Item 2: The minutes from the August 28, 2019 meeting were reviewed.

Mr. Johnny Deakins, Jr. made a motion for the board to approve the minutes of the August 28, 2019 meeting. Mr. Bob Browning seconded the motion. All approved. **Motion carried.** 

<u>Agenda Item 3</u>: Consider approval of a resolution to self-certify the metropolitan transportation planning process for the Johnson City MTPO that must accompany the adoption of the Transportation Improvement Program (TIP).

Mr. Glenn Berry explained that the TIP can't be adopted until the MPO has self-certified that the metropolitan planning process was carried out according to the Federal laws and regulations.

The Honorable Mayor Johnny Lynch made a motion for the board to approve the resolution to self-certify the metropolitan planning process. Mr. Jon Hartman seconded the motion. All approved. **Motion carried**.

<u>Agenda Item 4</u>: Consider approval of the Chair to sign the Memorandum of Agreement to define the need for Amendments and Administrative Modifications to the Transportation Improvement Program.

Mr. Berry explained that this Memorandum of Agreement (MOA) is renewed during each TIP cycle and defines the thresholds between amendments and administrative modifications (formerly called adjustments). The signed MOA will be included in the TIP.

Ms. Ronda Sawyer made a motion for the board to approve of the Chair to sign the Memorandum of Agreement. The Honorable Mayor Rusty Barnett seconded the motion. All approved. **Motion carried.** 

<u>Agenda Item 5</u>: Consider approval of a resolution to adopt the Fiscal Years 2020-2023 Transportation Improvement Program (TIP).

Mr. Berry showed a presentation to explain an overview of the TIP. He was happy to report that Congress had repealed the rescission that was due to take back over \$7 billion dollars in highway funding. He reviewed the local projects funding with the Johnson City MTPO's allocation of Surface Transportation Block Grant (STBG) funds. He also explained the funding shortfall for the Knob Creek Road project and that the city of Johnson City is looking at trying to reduce the cost of the project in order to find enough funding for construction. He also stated that Elizabethton had applied for a Transportation Alternatives grant to repair the Covered Bridge, and that grant awards will be announced by May 2020.

Mayor Barnett asked about the State Route 91 project. Specifically, he had heard concerns from citizens and business owners regarding the proposed changes for the "triangle" intersection of Elk, Roan, and Broad Streets. Mr. Berry asked Mr. Troy Ebbert who would be the best contact. Mr. Ebbert referred the question to Jason Farmer from TDOT. He stated that Mayor Barnett could contact the Elizabethton office and they can show him the plans and go over any concerns with him.

Mr. Hartman asked about the alternatives being considered for the Knob Creek project. Mr. Berry explained that Johnson City is diligently exploring alternatives to lower the cost of the project. He further stated that the City of Johnson City had requested the engineer of record to contact CSX railroad about the possibility of extending the road to an at-grade railroad crossing, rather than building a bridge. Mayor Brock stated she had been informed this option looked optimist but further discussions would be necessary. Washington County Highway Superintendent, Johnny Deakins, stated CSX often asked the county to be involved with at-grade railroad crossings. Mayor Brock stated it is good that everyone involved in the project was aware of the issue and wanted to work together. Mr. Berry stated he had been contacted by TDOT about the other section of Knob Creek Road from just north of Mizpah Hills Drive to Boones Creek Road, known as "SR-XXX" and they wanted to coordinate and discuss with the city and county on the typical cross section for both sections of Knob Creek Road. Mr. Berry stated TDOT would be setting up a call after the first of the year.

The final project discussed was the Jonesborough Parkway which had been included in two previous Metropolitan Transportation Plans. He stated TDOT was preparing a report on the project; however, the studies for projects in the IMPROVE Act had a higher priority, but he had been informed by TDOT Nashville the study was underway.

Mr. Berry stated that since the funding for the Knob Creek Project being managed by Johnson City from Mizpah Hills to Marketplace Boulevard and the Jonesborough Parkway did not have funding identified at this time, they would be listed in the 2020-2023 TIP as illustrative projects.

Mr. Browning made a motion for the board to adopt the Fiscal Years 2020-2023 TIP. Mr. Hartman seconded the motion. All approved. **Motion carried.** 

**Agenda Item 6**: Consider approval of a resolution to support Safety (PM1) Performance Targets by TDOT.

Mr. Berry explained that the safety performance targets are not meant to endorse that number of people dying on the roads in Tennessee. He said it would be wonderful if the number could be 0. TDOT goes through a lengthy process with a formula to calculate the targets. Ms. Mary Butler provided a handout that explains the target justification process. Mr. Berry explained that the Executive Board will vote to support TDOT on their targets.

Mayor Lynch made a motion for the board to approve the resolution to support the Safety (PM1) Performance Targets by TDOT. Mr. Bob Wilson seconded the motion. All approved. **Motion carried.** 

**Agenda Item 7**: Consider endorsement of prioritized projects for TDOT's Three-Year Work Program.

Mr. Berry went over the projects that were provided by TDOT for their next Three-Year Work Program. The Executive Board was asked to rank one project, the new state route along Knob Creek Road from Mizpah Hills to Boones Creek Road; however, the MTPO staff added the Jonesborough Parkway as a second project to the list, knowing that it's been considered for an environmental study with TDOT. The Jonesborough Parkway has been included in the last two Long Range Plans.

In addition to ranking two projects for the Johnson City MTPO, the Kingsport MTPO requested that we support three of their projects that would benefit the region as a whole. They are: completing SR 36 as a five-lane highway from SR 75 to I-81; establishment of ITS along the entire I-26 corridor; and improvements to the I-81/I-26 interchange. MTPO staff provided a recommendation of the two project rankings; the Kingsport projects will not be ranked.

Mr. Deakins made a motion for the board to approve the project rankings as recommended (SR-XXX Knob Creek project being number 1 and the Jonesborough Parkway being number 2) for TDOT's Three-Year Work Program. Mr. Jon Hartman seconded the motion. All approved. **Motion carried.** 

Agenda Item 8: Annual Listing of Obligated Projects.

Mr. Berry went over the handout for the annual listing of obligated projects. He said that Ms. Butler created the graphic summarizing the listing. He noted that there was \$22.4 million in federal funds obligated this year. There are a total of 32 projects and 17 projects were closed out. He wanted to note that some projects on the list were completed many years ago and are now being closed out. For some, that means funds in red are returned to the pot, to be obligated somewhere else. He also mentioned the graphic shows how many of each different project type are listed.

### Agenda Item 9: Other Business

Mr. Berry mentioned all items had been covered and reminded everyone the federal government including US DOT had been funded until September 30, 2020. There was discussion about the upcoming 2020 Census and how important it is for everyone to be counted. Mr. Berry also announced that there is a public meeting coming up on January 7 for the I-26 Multimodal Corridor Study in Kingsport. Ms. Butler passed out a flyer to the members.

## METROPOLITAN TRANSPORTATION PLANNING PROCESS CERTIFICATION

**Resolution 2020-02:** Consider approval of a resolution to amend the Fiscal Years (FY) 2020-2023 Transportation Improvement Program (TIP) to add additional funding to the Construction phase of the SR 34 at Industrial Park Rd Traffic Signal Upgrade Project and move it from FY 2020 to FY 2021

TDOT is managing the project for Bluff City to upgrade a traffic signal at the intersection of SR-34/11E/19E and Industrial Park Road. This intersection serves many companies located in the adjacent Tri-County Industrial Park, along with a traffic count of 26,880 AADT in 2019. Several of the signals are old and can no longer be serviced. The upgraded intersection has been designed and is ready to go out for bid sometime in early 2021. A revised estimate for construction was provided by TDOT staff and will require an amendment to increase the cost to cover the additional work to the intersection. The current amount for construction in the Fiscal Year 2020-2023 TIP is \$180,000. An additional \$235,000 is needed, for a new total of \$415,000 for construction. This project qualifies for 100 percent federal share. The new Total Project Cost is \$435,000. The Construction phase is also moving from FY 2020 to FY 2021.

It is recommended this item be approved by the Johnson City MTPO Executive Board by roll call vote and accompanying resolution.

### Consider endorsement of prioritized projects for TDOT's Three-Year Work Program

Each year the Tennessee Department of Transportation (TDOT) requests our input on **major** transportation projects to be included in TDOT's Three-Year Work Program. These major projects are managed by TDOT, which have traditionally been totally funded with TDOT resources that are available to the state, whether it be federal or state funds.

For the Johnson City MTPO area, the list of projects is the same as last year. There is one major project, preliminary engineering for the new state route on Knob Creek Road, that was initiated through the planning process, meetings with TDOT, and by informing our state legislators of our project needs. We are again recommending to add another project that was not on TDOT's list, the Jonesborough Parkway project.

#### **Annual Listing of Obligated Projects**

The Code of Federal Regulations, Section 450.332(a), states, "In metropolitan planning areas, on an annual basis, no later than 90 calendar days following the end of the program year, the State, public transportation operator(s), and the MPO shall cooperatively develop a listing of projects (including investments in pedestrian walkways and bicycle transportation facilities) for which funds under 23 U.S.C. or 49 U.S.C. Chapter 53 were obligated in the preceding program year." Title 23 of the United States Code provides funding for highway projects and Title 49 provides funding for transit projects.

The Johnson City MTPO received a listing of projects from TDOT for the federal fiscal year ending September 30, 2020. These projects were federally obligated by the Federal Highway Administration. Also included are projects obligated by area transit agencies by September 30, 2020. These projects were federally obligated by the Federal Transit Administration.



The graph to the right shows the federal sources that funded the most projects.


## WHAT TYPES OF PROJECTS WERE FUNDED?
