

**MEMORANDUM of AGREEMENT between the Johnson City Metropolitan
Transportation Planning Organization and the Kingsport Metropolitan Planning
Organization Pertaining to the Urbanized Area of Kingsport contained within the
Johnson City MTPO Long Range Planning Area
And
The Urbanized Area of Johnson City within the Kingsport MPO Long-Range
Transportation Planning Area**

This Memorandum of Agreement is between the Johnson City Metropolitan Transportation Planning Organization (“Johnson City MTPO”) and the Kingsport Metropolitan Planning Organization (“Kingsport MPO”) pertaining to extension of the Urbanized Areas into the planning areas in north Washington County, Tennessee, in the vicinity of Spurgeon Island Road and the area in north Washington County, Tennessee south of CSX railroad in the vicinity of I-26.

Relative to the following:

The long-range transportation planning activities and responsibilities for the portion of Washington County, Tennessee along Spurgeon Island road shown as “Area A” in Appendix A and the portion of Washington County, Tennessee south of CSX railroad in the vicinity of I-26 described in north Washington County, shown as Area B in Appendix A (attached).

I. IT IS UNDERSTOOD BY THE PARTIES:

- A. That the United States Bureau of the Census establishes boundaries for Urbanized Areas; and
- B. That the long-range transportation planning area boundaries surrounding the urbanized areas for Johnson City and Kingsport are defined by the Executive Boards of the Johnson City MTPO and Kingsport MPO; and
- C. That the area identified on the map in Appendix A as “Area A” is part of the Johnson City Urbanized Area, located in north Washington County, Tennessee in the vicinity of Spurgeon Island road and is contained within the Kingsport MPO planning area boundary for purposes of long-range transportation planning; and
- D. That the coordination and implementation of any transportation projects located in “Area A” as identified on the map in Appendix A, located in the vicinity of Spurgeon Island road in the northern section of Washington County, Tennessee, will be the responsibility of the Kingsport MPO; and
- E. That the area identified on the map in Appendix A as “Area B”, located in north Washington County, Tennessee south of CSX railroad and in the vicinity of I-26 is part of the Kingsport Urbanized Area and is contained within the Johnson City MTPO planning area for purposes of long-range transportation planning; and
- F. That the coordination and implementation of any transportation projects located in Appendix A as “Area B”, located south of CSX railroad in the

vicinity of I-26 in the northern section of Washington County, Tennessee will be the responsibility of the Johnson City MTPO.

II. IT IS THE INTENTION OF THE PARTIES:

- A. The boundary dividing the Johnson City MTPO long-range transportation planning area from the Kingsport MPO long-range transportation planning area in Washington County, Tennessee, will be redefined following release of the 2010 data by the United States Bureau of the Census by mutual agreement of the Executive Boards of the Johnson City MTPO and the Kingsport MPO.
- B. The Johnson City MTPO and the Kingsport MPO will continue their long-standing practice of cooperation in the processes of long-range transportation planning in Washington County, Tennessee.



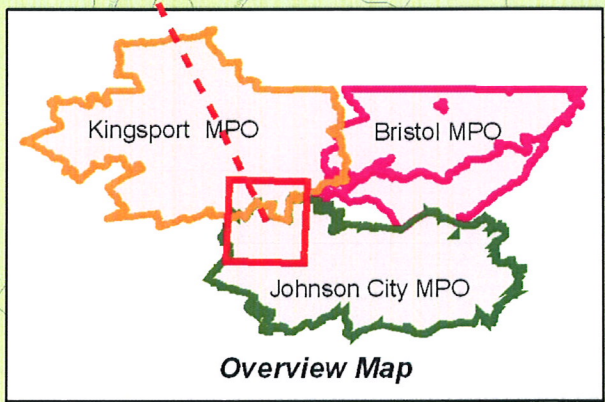
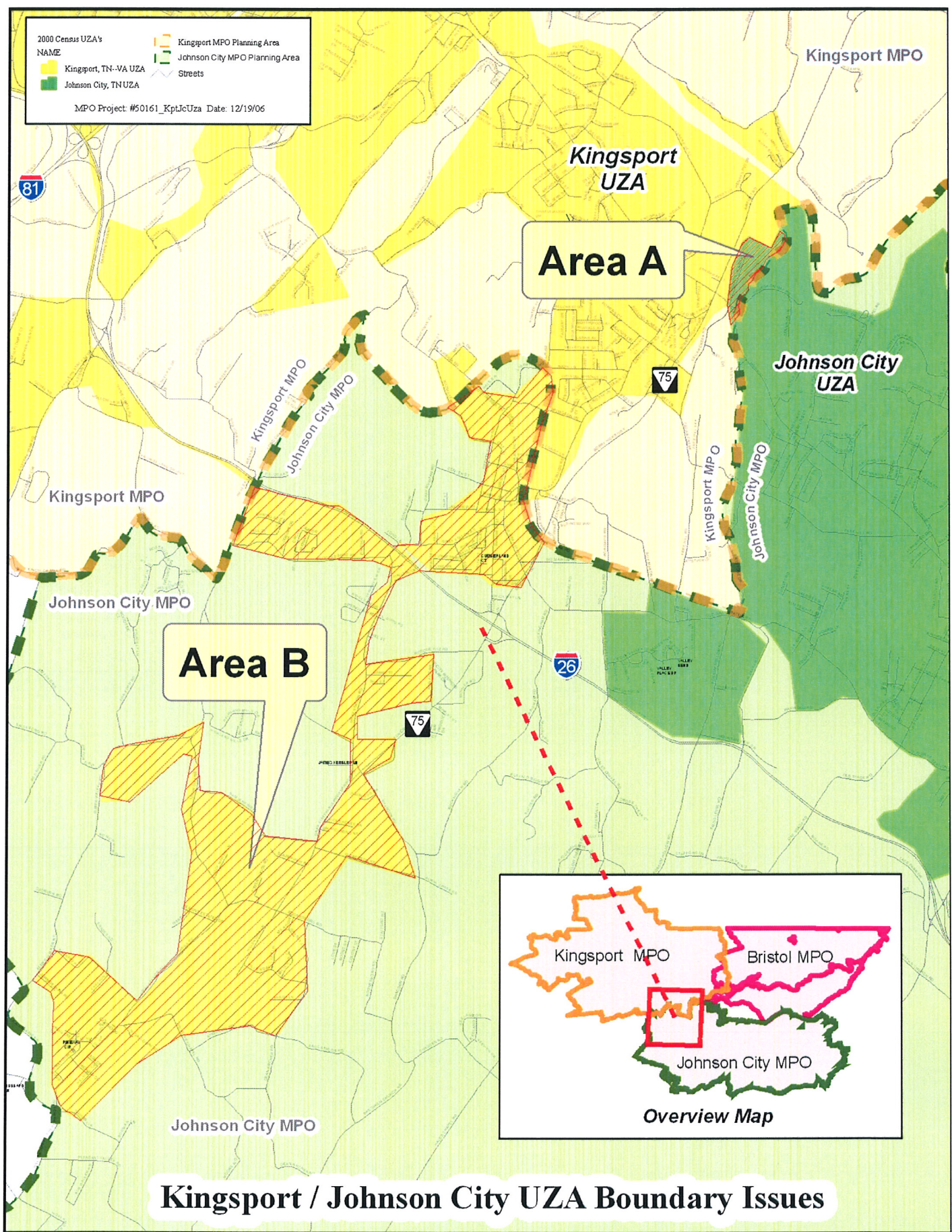
