The Johnson City MTPO is comprised of two boards, the Executive Board and the Executive Staff. The official decision making body is the Executive Board. All members of the Executive Board are the chief elected official of each member jurisdiction, thus they are elected by the public. The Executive Staff serves as the technical advisory committee. The Executive Staff is comprised of the chief administrator of the representing agency and are hired by the governing body of the agency.

The By-Laws list the members of each body and are attached as Addendum III-2a and III-2b. Per Tenn. Code Ann. § 64-8-301, the Executive Board includes a member of the Tennessee County Highway Officials Association.

The Executive Board and the Executive Staff meet as needed throughout the year; however, each body is required to meet, at a minimum, at least once a year.

The meetings are advertised as open to the public. At the beginning of each meeting, the public is given the opportunity to address the Board. The MTPO staff is available to speak to community groups and also presents at the city's Citizens Academy. Any group can schedule a presentation to the Board. The meetings are held at the Transit Center for the convenience of those who ride transit. The Johnson City MTPO is also active on social media, using Twitter and Facebook. The website is kept up to date with all documents available.

#### Addendum III-2a

#### BY-LAWS OF THE JOHNSON CITY URBAN AREA METROPOLITAN TRANSPORTATION PLANNING ORGANIZATION EXECUTIVE BOARD

#### Article I -Name

The name of the organization shall be the Johnson City Urban Area Metropolitan Transportation Planning Organization Executive Board.

#### Article II - Membership

The Executive Board shall be composed of principal elected officials of governmental jurisdictions participating in the Johnson City Urban Area transportation planning process.

And one Executive Board member shall be appointed by the Tennessee County Highway Officials Association per Tennessee State Law, Public Chapter NO. 479 signed into law by the Governor on May 18, 2015. The following officials shall constitute the Executive Board membership:

> State of Tennessee: Governor Town of Bluff City: Mayor City of Elizabethton: Mayor City of Johnson City: Mayor Town of Jonesborough: Mayor Town of Unicoi: Mayor Carter County: County Mayor Washington County: County Mayor Tennessee County Highway Officials Association: Appointed by Association

#### Article III - Duties

The Executive Board constitutes the forum for cooperative transportation decisionmaking in the Johnson City Urban Area. As such it shall carry out the following responsibilities:

- 1. Overall MTPO policy;
- 2. Administrative and fiscal control;
- Review and approval of all transportation planning, programming, and implementation activities within the purview of the MTPO;

4. Establishment of ad hoc committees as necessary to carry out special projects or studies.

#### Article IV - Organization

1. Organization of the Executive Board shall consist of a Chairman, a Vice-Chairman, and a Secretary.

2. The Mayor of Johnson City shall serve as Chairman of the Executive Board.

3. The Vice-Chairman shall be elected from the membership of the Board by majority vote of a quorum at the first Board meeting of each calendar year. The term of office of the Vice-Chairman shall be one year, or until a new election is held. There shall be no limitation on the number of successive terms a Vice-Chairman may serve, provided membership on the Executive Board is maintained.

4. The Transportation Planning Coordinator shall serve as permanent Secretary to the Executive Board.

#### <u>Article V - Duties of Chairman</u> <u>and Vice-Chairman</u>

1. The Chairman shall preside at all meetings of the Executive Board.

2. The Chairman shall authenticate by signature all resolutions adopted by the Executive Board.

3. The Chairman, or designated representative, shall represent the Executive Board at hearings, conferences, and other events as required.

4. In the absence of the Chairman, the Vice Chairman shall discharge all duties of the Chairman.

#### Article VI - Duties of the Transportation Planning Coordinator

1. The Executive Board shall appoint a Transportation Planning Coordinator to carry out certain administrative and planning duties as determined by the Executive Board and by statute.

2. The Transportation Planning Coordinator shall be under the administrative jurisdiction of the City of Johnson City but shall be under the overall direction of the Executive Board.

#### Article VII - Meetings

1. The Executive Board shall meet annually or as required to maintain administrative control on the planning and implementation process.

2. Each member of the Executive Board may designate an alternate to attend meetings and conduct business in the member's absence.

3. A simple majority of the Executive Board membership or designated alternates shall constitute a quorum. A quorum shall be necessary for the official transaction of Board business.

#### Article VIII - Amendment

These by-laws may be amended by a majority vote of a quorum at any Executive Board meeting.

#### Addendum III-2b

#### BY-LAWS OF THE JOHNSON CITY URBAN AREA METROPOLITAN TRANSPORTATION PLANNING ORGANIZATION EXECUTIVE STAFF

#### Article I -Name

The name of the organization shall be the Johnson City Urban Area Metropolitan Transportation Planning Organization Executive Staff.

#### Article II - Membership

The Executive Staff shall be composed of representatives of governments and agencies having functional responsibility for transportation planning and implementation in the Johnson City Urban Area. The Executive Board may designate additional Executive Staff representation as necessary. The following officials shall constitute the Executive Staff membership:

State of Tennessee, Department of Transportation Town of Bluff City: City Manager City of Elizabethton: City Manager City of Johnson City: City Manager Town of Jonesborough: Town Administrator Town of Unicoi: Town Recorder Carter County: Highway Superintendent Washington County: Highway Superintendent First Tennessee Development District, Executive Director Johnson City Transit System: Director

\*\*Federal Highway Administration: Division Administrator \*\*Federal Transit Administration: Regional Administrator

\*\*Non-Voting Members

#### Article III – Duties

1. The Executive Staff is responsible for carrying out the transportation planning program for the Urban Area under the direction of the Executive Board.

2. The Executive Staff shall receive and review reports, plans, documents, and programs prior to presentation to the Executive Board for final approval.

3. The Executive Staff shall be responsible, together with the Transportation Planning Coordinator, for coordination of all transportation planning, programming, and implementation activities among the various jurisdictions and agencies comprising the MTPO.

#### Article IV – Organization

1. Organization of the Executive Staff shall consist of a Chairman, a Vice-Chairman, and a Secretary.

2. The Chairman and Vice Chairman of the Executive Staff shall be elected by majority vote of a quorum of the Executive Staff. The terms of office shall be one year or until a new election is held.

3. There shall be no limitation on the number of successive terms a member may serve as Chairman or Vice Chairman, provided the membership on the Executive Staff is maintained.

4. The Transportation Planning Coordinator shall serve as permanent Secretary to the Executive Staff.

#### <u>Article V - Duties of Chairman</u> and Vice-Chairman

1. The Chairman shall preside at all meetings of the Executive Staff.

2. The Chairman shall authenticate by signature all resolutions adopted by the Executive Staff.

3. The Chairman shall represent the Executive Staff at Executive Board meetings, hearings, conferences, and other events as required.

4. In the absence of the Chairman, the Vice-Chairman shall discharge all duties of the Chairman.

#### Article VI - Duties of the Transportation

#### Planning Coordinator

1. The Transportation Planning Coordinator shall coordinate and schedule all meetings of the Executive Staff, record the proceedings, and prepare and distribute the minutes thereof.

2. The Transportation Planning Coordinator shall prepare necessary resolutions and documents for Executive Staff consideration and shall ensure that such resolutions and documents are distributed to all Executive Staff members prior to meetings.

3. The Transportation Planning Coordinator shall coordinate all activities of the Johnson City Urban Area MTPO and, with technical staff assistance, shall accomplish analyses, documentation, and other responsibilities as assigned.

#### <u>Article VII – Meetings</u>

1. The Executive Staff shall meet as necessary to achieve coordination in the transportation planning, programming, and implementation process.

2. Each member of the Executive Staff may designate an alternate to attend meetings and conduct business in the member's absence.

3. Fifty per cent (50%) of the voting of Executive Staff members or designated alternates shall constitute a quorum for the purpose of conducting business.

#### Article VIII - Amendment

These by-laws may be amended by a majority vote of a quorum at any Executive Staff meeting.

## Appendix V - Title VI and Environmental Justice Assessment

The specific civil rights concerns with transportation projects revolve around Title VI of the Civil Rights Act and Environmental Justice requirements (E.O.12898 Federal Action to Address Environmental Justice in Minority Populations and Low-Income Populations). US DOT's policy is to ensure compliance with 42 U.S.C. 2000 "No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under a program or activity receiving federal financial assistance from the Department of Transportation." E.O. 12898 requires each agency (including the US DOT) to "make achieving environmental justice part of its mission by identifying and addressing, as appropriate, disproportionately high and adverse human health or environmental effects of its programs, policies, and activities on minority and low-income populations". US DOT issued its Order on Environmental Justice (DOT Order 5610.2) in response to clarify Title VI responsibilities. Adverse impacts related to transportation projects include:

- Bodily impairment, infirmity, illness, or death.
- Air, noise, and water pollution; and soil contamination.
- Destruction or disruption of man-made or natural resources.
- Destruction or diminution of aesthetic values.
- Destruction or disruption of community cohesion or a community's economic vitality.
- Destruction or disruption of the availability of public and private facilities and services.
- Vibration.
- Adverse employment effects.
- Displacement of persons, businesses, farms, or nonprofit organizations.
- Increased traffic congestion, isolation, exclusion, or separation of minority or lowincome individuals within a given community or from the broader community.
- The denial of, reduction in, or significant delay in the receipt of benefits of DOT programs, policies, or activities.

The DOT Order ensures that there will be greater public involvement opportunities and access to information on transportation activities affecting the human health and the environment. A requirement of the E.O. 12898 and the DOT Order concerns Limited English Proficiency (LEP) people. Discrimination against people who are Limited English Proficient was determined to be a form of national origin discrimination forbidden by Title VI of the Civil Rights Act.

Metropolitan planning organizations are required to consider three fundamental environmental justice principles:

- 1. To avoid, minimize, or mitigate disproportionately high and adverse human health and environmental effects, including interrelated social and economic effects, on minority populations and low-income populations.
- 2. To ensure the full and fair participation by all potentially affected communities in the transportation decision-making process.
- 3. To prevent the denial of, reduction in, or significant delay in the receipt of

benefits by minority populations and low-income populations.

Metropolitan planning organizations are required to consider environmental justice early in the planning process and (1) determine benefits to and potential negative impacts on minority populations and low-income populations from proposed investments or actions; (2) quantify expected effects (total, positive and negative) and disproportionately high and adverse effects on minority populations and low-income populations; and (3) determine the appropriate course of action, whether avoidance, minimization, or mitigation. (This is a discussion of environmental justice and planning, but the requirements apply across the whole range of transportation activities including contracting for services, and require the recipients, i.e. the MTPO, and the urbanized areas in Sullivan, Washington, Carter, and Unicoi Counties, to do things such as monitor minority participation in contracts and maintain a complaint system for addressing Title VI complaints, etc.).

The following sections provide an assessment of potential impacts to the low-income and minority population groups within the Johnson City Metropolitan Transportation Planning Organization (MTPO) area based on implementation of the transportation projects within the 2045 Metropolitan Transportation Plan (MTP). The analysis was done using the MTPO's geographic information system (GIS) and US Census Block Group data. The 5- Year Estimate (2009-2013) US Census American Community Survey (ACS) Population and Housing Characteristics data were used for this assessment with data being used at the US Census Block Group level. A senior population analysis (persons over the age of 65) was also undertaken given the size of this population group in the MTPO area and their vulnerability over time to transportation decisions (i.e. availability of income to transportation costs, mobility limitations, etc.).

## **Minority Population**

According to the 2009-2013 ACS data, approximately 7% of the Johnson City MTPO region's residents are considered to be minorities (non-white). As shown in Table 1, the region's minority population is comparable to those of Carter, Sullivan, Washington, and Unicoi counties in the MTPO area. When compared with the share of minority population for Tennessee, the MTPO's share of minority population is considerably smaller. It should be noted that the populations shown in this table are based on ACS estimates and therefore may not align with the existing population in 2015 detailed in the MTP document.

In the following subsections, the positive and negative effects of the 2045 MTP's highway, transit, and bicycle/pedestrian improvements on concentrations of minority populations are discussed by type of improvement. The highway projects (both funded and unfunded) in the 2045 MTP include roadway widening projects, new roadways, reconstruction of roadways, signal improvements, and intersection improvements. In some cases, sidewalks and/or bicycle facilities may be included as part of a highway project and are noted in the analysis. Additionally, expansion in transit services and routes in areas with concentrations of minority, senior, and low-income populations will have positive impacts on the transportation system in these areas.

#### HIGHWAY IMPROVEMENTS

There are a total of 59 Census Block Groups within the Johnson City MTPO area that will be directly affected by the 2045 MTP highway transportation improvement projects. Of the total MTPO Population estimated by the ACS data (161,359 people), the share within the affected Census Block Groups is 59% and the share of the total MTPO minority population (11,131 people) is 54%. Within the 59 Census Block Groups, a total of 95,167 people reside, of which 6% are minority, as seen in Table 2.




Figure 1 Highway Improvements in Minority Population Areas

The next step was to look at the Census Block Groups within the affected area (the 59 Block Group area) in which the share of minority population is higher than the MTPO region's percentage of minority population (7%). Of the 59 Block Group affected area, 22 Block Groups have over 7% minority population (See Table 3 and Figure 1).

For the purposes of this EJ analysis, those individual Block Groups where the share of minority population is double that of the MTPO area (or 14% minority or higher) are considered to potentially contain an environmental justice population and are referred to as "communities of concern". Eight Census Block Groups are part of the "communities of concern". A total of 2,337 minority people reside in those eight Block

Groups, representing about 21% of the total number of minority people in the MTPO area (11,131 people). All but one of these eight Block Groups are located in Washington County.

A more detailed review, including positive and negative impacts of the projects in the communities of concern was conducted. The projects' affects include improving traffic congestion, adding transportation options by including bicycle and pedestrian modes, improving access to transit, and possibly affecting right-of-way due to new roadways, roadway widening, or reconstruction.

The highway projects in the 2045 MTP that would fall within the minority population of at least 7% were identified. Eighteen improvements fall into this category consisting of new roadways and roadway widenings; roadway reconstructions and realignments; bridge replacements and rehabilitations; interchange ramp improvements; signal and intersection improvements; and safety-related projects. The signal and intersection improvements should improve the traffic flow in the areas. Also, the safety improvements should improve the transportation network so these projects would have a positive impact on the population. The improvements to bridges and interchanges are primarily related to safety, not capacity. That leaves the road widening and new construction projects which may adversely affect the population and require mitigation steps be taken. These 18 projects are listed in Table 4 with project descriptions and funding year.

#### TRANSIT IMPROVEMENTS




Figure 2 Existing System Transit Improvements in Minority Population Areas

For the purposes of the EJ analysis minority population assessment, the MTPO reviewed areas that are currently served by the Johnson City Transit Service's (JCT) fixed-route bus service. The routes are shown in Figure 2. JCT provides service in an area comprised of 50 Census Block Groups. According to the 2009-2013 5-Year ACS estimates, approximately 66,294 people reside in the service area, representing 41% of the total MTPO population (161,359 people) (see Table 5). In that service area, 12% of the residents are minority people; the minority residents in this area represent 69% of the region's total minority population (11,131 people). By comparison, the percentage of non-minority people in the 50 Block Group service area represents 39% of the region's total non-minority population (150,228 people).

The next step was to look specifically at those Census Block Groups in which the share of minority population was equal to or greater than the MTPO region's percentage of minority population (7%) and that are served by the JCT system. A total of 32 Block Groups have minority populations of at least 7% and are served by the JCT system (See Table 6 and Figure 2). Approximately 62% of the region's total minority population resides in those 32 Block Groups.

As discussed in the previous section "communities of concern" consist of those Block Groups where the minority population is double that of the MTPO area (at least 14% minority). For the existing transit service affected area, 17 Census Block Groups have double the MTPO average share of minority people; these 17 Block Groups represent about 45% of the MTPO region's total minority population. These Block Groups are located primarily in and around downtown Johnson City.

The 2045 MTP contains a list of projects to enhance the existing transit services. Planned public transportation improvements over the 25-year plan horizon are geared toward system expansion including more routes, extended service hours, more bus shelters, and following a normal vehicle replacement schedule. The transit projects are expected to enhance the service for the entire 50 Census Block Group area.

## Low-Income Population

According to the 2009-2013 ACS data, approximately 20% of the households located within the MTPO region reported incomes below the federal poverty level (referred to as "low-income" in this analysis). As shown in Table 7, the region's low-income population is in line with the four counties comprising the region, but slightly higher than the state average.

In the following sections, the effects of the 2045 MTP's highway improvements and the transit system on low-income populations are discussed by type of improvement.

#### HIGHWAY IMRPOVEMENTS




Figure 3 Highway Improvements in Low-Income Population Areas (Below Poverty)

As mentioned previously, 59 Census Block Groups would be directly affected by the 2045 MTP roadway transportation improvement projects, shown on Figure 3. Within those Census Block Groups, there are a total of 40,310 households, of which 17% (6,829 households) are reported to be low-income (see Table 8).

The next step was to look at the Census Block Groups within the affected area (the 59 Block Group area) in which the share of low-income households is higher than the MTPO region's percentage of low-income households (20%). Of the 59 Block Group affected area, 21 Block Groups have a 20% or higher low-income households (See Table 9 and Figure 3).

Six Census Block Groups contain concentrations of low-income households that are at least double the regional average, or at least 40%. These Census Block Groups, identified as "communities of concern" are primarily located in downtown Johnson City and contain approximately 9% of the total low-income households (13,275 households) in the entire MTPO area.

To determine both the positive and negative impacts on the low-income population in the affected area the highway projects were evaluated. Twelve highway projects fall in Census Block Group areas with over 20% low-income households consisting of new roadways and roadway widenings; roadway reconstructions and realignments; bridge replacements and rehabilitations; interchange ramp improvements; signal and intersection improvements; and safety-related projects. Positive effects by the signal and intersection improvement projects expected to be seen include improved traffic flow in the area. In addition, the safety improvements should have positive effects on the population. The 12 new roadway projects which may have a negative impact on the population are listed in Table 10.

#### TRANSIT IMPROVEMENTS

As mentioned previously, JCT's current fixed-route bus service is provided to 50 Census Block Groups. In that service area, approximately 66,294 people reside in approximately 28,352 households (see Table 11). Also in that service area, 23% of the households are considered low-income. For comparison, the percentage of low-income households in the transit service area represents about 49% of the region's total low-income population (13,275) and about 40% of the regions non-low income households (54,075). The existing fixed-route transit service is focused in the Downtown Johnson City area serving about 49% of the low-income population.


The next step was to look specifically at those Census Block Groups in the existing transit service area in which the share of low-income population is equal to or greater than the region's percentage of low-income population (20%). Twenty-three of the Census Block Groups served by transit have low-income populations of at least 20% (See Table 12 and Figure 4). These 23 Census Block Groups serve about 36% of the total MTPO low-income population (4,718 households).

There are 10 Census Block Groups that have low-income populations that meet or exceed 40%; thus, these Census Block Groups which are provided transit service are considered to be "communities of concern" for low-income populations. These Census Block Groups are mostly located in the Johnson City limits.

The 2045 MTP contains a list of projects to enhance the existing transit services. Planned public transportation improvements over the 25-year plan horizon are geared toward system expansion including more routes, extended service hours, more bus shelters, and following a normal vehicle replacement schedule. The transit projects are expected to enhance the service for the entire 50 Census Block Group area.





## Senior Population (Over 65)

According to the 2009-2013 ACS 5-Year estimates, approximately 16% of the population of the MTPO region is 65 years of age or older (referred to as "senior" in this analysis). As shown in Table 13, the region's senior population is lower than that of Sullivan, Carter, and Unicoi Counties.

In the following sections, the effects of the 2045 MTP's highway and transit improvements on senior populations are discussed by type of improvement.

#### HIGHWAY IMPROVEMENTS




Figure 5 Highway Improvements in Senior Population Areas (Over 65)

As mentioned previously, 59 Census Block Groups will be directly affected by the MTP's proposed highway improvement projects, shown on Figure 5. Within those Census Block Groups, a total of 95,167 people reside, of which 16% (15,538 people) are reported to be in the senior population (see Table 14). The share of the senior population within the affected Census Block Groups (16%) is similar to the overall share of senior population within the MTPO area.

Evaluation of the Census Block Groups within the affected area (the 59 Block Group area) in which the share of senior population is compared to the MTPO region's percentage of senior population was conducted. Of the 59 Block Group affected area, 34 block groups have at least 16% senior population (See Table 15 and Figure 5). Five Census Block Groups contain concentrations of senior populations that are at least double the regional average, (or at least 32%) and therefore are communities of concern. These five Census Block Groups contain approximately 39% of the total senior population (26,274 people) in the entire MTPO area.

Twenty-five highway projects are within Census Block Group areas that have a senior population over 16% consisting of new roadways and roadway widenings; roadway reconstructions and realignments; bridge replacements and rehabilitations; interchange ramp improvements; signal and intersection improvements; and safety-related projects. These 25 projects are listed in Table 16.

#### TRANSIT IMPROVEMENTS

As mentioned previously, JCT's current fixed-route bus service provides service in an area that comprises 50 Census Block Groups. In that service area, approximately 66,294 people reside (see Table 17) of which 15% of the residents fall into the senior population. The existing fixed-route transit service is focused in the Downtown Johnson City area.



The next step was to look specifically at those Census Block Groups in the existing transit service area in which the share of senior population is equal to or greater than the region's percentage of senior population (16%). Twenty-five Census Block Groups have senior populations of at least 16% (See Table 18 and Figure 6). Of the 25 Census Block Groups identified, 18 have a senior population ranging between 16% and 32%. The remaining seven Census Block Groups have a senior population of 32% or more, which are the only Census Block Groups considered a community of concern for the senior population.

#### <u>Summary of Burdens</u>

Segments of the population that live adjacent to roadway construction projects may endure short-term construction-related impacts related to visual changes, noise, and traffic patterns. Although some of the roadway widening and new construction projects proposed in the 2045 Johnson City MTP will be adjacent to or through areas with minority, low-income, or senior populations, the projects will not disproportionately affect them. Also, some of the projects will include pedestrian and bicycle facilities, which will benefit minority, low-income, and senior populations. The safety and traffic management projects in the area should improve the flow of traffic through the communities of concern.

Lastly, to ensure that all people are considered and involved in the ultimate outcomes of the 2045 MTP (and corresponding transportation improvements), efforts by the MTPO, its member jurisdictions, and TDOT during the project development process should consider special outreach efforts for areas identified as communities of concern to help mitigate any adverse impacts and/or burdens from transportation improvements.



#### JOHNSON CITY MTPO TITLE VI COMPLAINT INVESTIGATION PROCEDURE

Any complaint alleging that the Johnson City Metropolitan Transportation Planning Organization (MTPO), a department of the City of Johnson City, has not complied with Title VI regulations must be submitted in writing to the Human Resources Director, City of Johnson City, 601 E. Main Street, Johnson City, TN, 37601. A written complaint must be filed within 180 days after the date of the alleged discrimination, unless the time for filing is extended by the Federal Transit Administration. The written complaint will, at a minimum, provide the following information:

- 1. the specific act(s) of the MTPO non-compliance in question;
- 2. the date(s) of MTPO non-compliance in question;
- specify the reasons why the complaining party believes that MTPO is not in compliance with the Title VI regulation(s) in question (including noncompliance in employment with MTPO);
- 4. the name and address of the complainant (and person discriminated against if different from complainant); and
- 5. if applicable, the Title VI minority status of the complainant (or person discriminated against if different from complainant).

Upon receipt of the written Title VI Complaint, the City's Human Resource Director will contact the following applicable City staff to provide a summary of the complaint, and request assistance with the investigation of the complaint:

- 1. the MTPO Title VI Coordinator;
- 2. the MTPO MPO Manager.

The HR Director, the MTPO Title VI Coordinator and/or the MTPO MPO Manager will coordinate efforts into investigating the act(s) of non-compliance with Title VI regulations alleged in the complaint and in preparing a written response, which will be completed within 10 business days from the date the City HR Director contacts the MTPO MPO Manager, and/or the MTPO Title VI Coordinator regarding the complaint. The investigation activities may include, as applicable, review of MTPO Title VI-related procedures, interviews with MTPO employees, the complainant, and any witnesses to the alleged discrimination. Upon completion of the investigation, the original complaint and all information obtained during the investigation of the complaint will be submitted to the City Manager.

Upon review of the written investigation submission and any independent investigation deemed appropriate conducted by the City, the City Manager will either:

1. Render a decision which will be final, and advise all interested parties of this decision in writing; or

- 2. City Manager, at his/her sole discretion, may conduct an informal hearing at which the interested participating parties will be afforded an opportunity to present their respective position, including facts, documents, justification, and technical information in support thereof.
  - a) If the City Manager conducts an information hearing, the parties may be, but are not required to be, represented by counsel. The informal hearing will not be subject to formal rules of evidence or procedures.
  - b) Following the informal hearing, the City Manager will render a decision, which will be final, and advise all interested parties thereof in writing.

Parties dissatisfied with the final decision of the City Manager, whether following review of the written submission or informal hearing, may contact the Tennessee Department of Transportation Civil Rights Office, the FHWA or FTA Civil Rights office, the U.S. Department of Transportation Civil Rights office and/or the U.S. Department of Justice.

A *Title VI Complaint Form* has been prepared for complainants to use, at their discretion, to file their complaint with one of these agencies (addresses included on form), or with the City of Johnson City.

#### Addendum III-13

#### **Description of the Johnson City MTPO Planning Process**

The planning process for the Johnson City MTPO is a continuing cycle that follows, among other things, the three "C" principles - continuing, comprehensive and cooperative. The process is driven by the development of the Johnson City MTPO Metropolitan Transportation Plan (MTP), or, as is sometimes referred to as the "Long Range Transportation Plan." Projects from the MTP are then incorporated in the development in the Transportation Improvement Program.

The Unified Planning Work Program outlines the work to be carried out by the MTPO staff out for a two-year period. In the development of these plans and programs, Title VI and Environmental Justice are included as part of the planning process.

#### **Metropolitan Transportation Plan**

Federal law requires that MPOs ensure that *individuals* not be excluded from participating in, denied the benefit of, or subject to discrimination under any program or activity receiving federal funding on the basis of race, color, national origin, age, sex, or disability.

While Title VI and Environmental Justice (EJ) concerns have most often been raised during project development, it is important to recognize that the law also applies equally to the processes and products of planning. Title VI of the Civil Rights Act prohibits discrimination on the basis of race, color, or national origin. Environmental Justice Executive Order 12898, Federal Actions to Address Environmental Justice (EJ) in Minority and Low-Income Populations, calls for the identification and addressing of disproportionately high and adverse human health or environmental effects of its programs, policies and activities on minority and low-income populations.

Title VI and Environmental Justice Assessment documents the MTPO's efforts to determine benefits and burdens to EJ communities within the MTPO area relative to the 2045 MTP. The analysis indicates that in general, neither low-income nor minority populations in the region would endure high and disproportionate impacts due to the projects proposed by the 2045 MTP. Complete findings of this assessment, potential project impacts, and mitigation strategies are presented in Appendix V of the 2045 MTP. https://jcmpo.org/mtp/2045/JCMTPO\_2045\_MTP.pdf.


In the development of the 2045 MTP, an environmental assessment of historic, cultural, and natural resources was developed to address provisions of the FAST Act. The intent of this analysis is to incorporate environmental considerations early in the planning process so that project development processes are more streamlined, by including realistic assumptions of potential environmental considerations, impacts, and costs.

To this end, the MTPO requests public input from all people, throughout the development of the MTP. This is done through public meetings, online surveys, social media and interactive project maps that allow people to make project suggestions and the MTPO always takes comments from the public.

#### **Transportation Improvement Program**

Similar to the MTP process, the Transportation Improvement Program (TIP) for the Johnson City MTPO considers the provisions in Title VI and Environmental Justice. Title VI of the Civil Rights Act of 1964 prohibits discrimination based upon race, color, or national origin. Specifically, Title 42 of the U.S.C., Section 2000d states, "No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." Environmental Justice Executive Order 12898 of 1994 states, "Each Federal agency shall make achieving environmental justice part of its mission by identifying and addressing, as appropriate, disproportionately high and adverse human health or environmental effects of its programs, policies, and activities on minority populations and low-income populations." In addition to the Executive Order, the US DOT issued Order 5610.2(a), which provides directive about how Environmental Justice communities are to be addressed in the planning process.

All projects using federal highway trust funds for the Johnson City MTPO comply with Title VI and Environmental Justice. During the development of the TIP, the MTPO staff used GIS to analyze projects in relationship to minority populations.

The map displays the census block groups in the four-county region according to their percent of minority population compared to a threshold of 9.3 percent for the Johnson City Urbanized Area, along with the TIP project locations, which increase safety and ease of access. The Johnson City MTPO has procedures for addressing Title VI complaints by making available a complaint form and an instruction

document, in both English and Spanish languages, on our website at <u>https://jcmpo.org/titlevi.html</u>. Staff also publishes a Title VI notice in the Johnson City Press annually, in both English and Spanish languages. The TIP document can also be translated into another language, upon request. Project development processes are more streamlined, by including realistic assumptions of potential environmental considerations, impacts, and costs.

#### **Unified Planning Work Program**

The Johnson City MTPO will continue to advocate for the fair treatment and meaningful involvement of all people regardless of race, color, national origin, sex, income, and disability in the development of the Unified Planning Work Program (UPWP). This document outlines the administrative activities and studies that are undertaken by the MTPO. As part of these administrative activities, the Johnson City MTPO maintains an active Title VI program which is reviewed by the TDOT Civil Rights Office on a triennial basis. The most recent Title VI Assessment can be found on the website at <a href="https://jcmpo.org/titlevi.html">https://jcmpo.org/titlevi.html</a>. The assessment will be posted after review by TDOT's Civil Rights Division. The webpage currently provides contact information for the Title VI Coordinator, along with forms for the complaint process. All projects using federal highway and transit funds for the Johnson City MTPO comply with Title VI and Environmental Justice.

There have been no discrimination complaints filed against the MTPO in the last year. The MTPO continually accepts comments on the transportation planning program and is available for community meetings, workshops, civic groups and individual meetings with the public in a nondiscriminatory manner.

The MTPO strives to program studies that benefit the region as a whole. The MTPO has a strong partnership with area transit agencies. Recently, the MTPO assisted Johnson City Transit with several planning projects in the past, one of which was the completion of a Comprehensive Operational Analysis and the assistance of a consultant to write the specifications for procuring new buses. The MTPO also plans to fund in the next year an analysis on the impact of potentially becoming a large urbanized area, with the status of a Transportation Management Area, and study its impact on transit funding and distribution process for the region.

# Recommendations for updating the Public Participation Plan based on the above performance of Outreach Methods:

- 1. Recommend the removal of eight of the nine locations currently listed as Appendix C Locations for review of MTPO and Transit Documents:
  - a. For the past three years (as far back as 2008), no comments have ever been received from the public using this outreach method;
  - b. Staff will continue to have copies of the documents available to the public at the Johnson City MTPO office located at the Johnson City Transit Center; and
  - c. Documents will continue to be available online, on the Johnson City MTPO website at <u>www.jcmpo.org</u>; all area libraries and city/town halls have internet access in which the public can access the documents available online.
- 2. Recommend continuing the public hearings held during document public comment review periods:
  - a. Very few participants attend these hearings; however, the Johnson City MTPO will continue to hold these hearings in addition to the meetings of the Executive Board to adopt these documents.
- 3. Recommend using Google Analytics to begin tracking website statistics for the Johnson City MTPO website:
  - a. The host service for the Johnson City MTPO website, <u>www.jcmpo.org</u>, ended its service to provide website statistics in 2014;
  - b. Google Analytics is a free web analytics service that provides statistics and basic analytical tools for data visualization and custom reports; and
  - c. Staff has begun an account with Google Analytics and is now tracking website statistics through this method.

#### 2017 Cursory Review

In 2017, staff considered making changes to the placement of legal notices in the Johnson City Press, the regional newspaper, to mirror the practice recommended by TDOT. As the Johnson City MTPO is currently in the process of updating its Long Range Transportation Plan (LRTP), staff declines to make changes at this time. Staff will revisit this item for the next UPWP, as the LRTP process will have concluded.

### Addendum IV-3

### Limited English Proficiency Policy

This document describes the Limited English Proficiency (LEP) Policy for the Johnson City Metropolitan Transportation Planning Organization (MTPO). Executive Order 13166 for Limited English Proficiency was signed on August 11, 2000 and directed federal agencies and their recipients to improve access for LEP individuals to federally-conducted and federally assisted programs and activities. As a recipient of federal funding, the Johnson City MTPO is required to improve access for LEP individuals to the transportation planning process. The following Four Factors Analysis was conducted to ensure meaningful and appropriate access for LEP individuals identified in the Johnson City area.

#### Four Factors Analysis

# Factor 1: Number or proportion of LEP persons eligible to be served or likely to be encountered by a program, activity, or service of the grantee.

Table 4 below shows the number and percentage of the population in the Johnson City Urbanized Area, identifying the language they speak at home and how well they speak English.

According to Table 4, almost 5% of the households in the Johnson City Urbanized Area speak a language other than English. Of those, about half (48%) speak Spanish. 1,224 people, or 1.1%, speak English less than very well. This population is considered Limited English Proficiency.

# Factor 2: The frequency with which LEP individuals come in contact with the program, activity, or service.

The Johnson City MTPO staff assessed, as accurately as possible, the frequency with which LEP individuals come in contact with any programs, activities or services that have been provided by the Johnson City MTPO in the past. To date, the Johnson City MTPO has received no requests, formal or otherwise, by LEP individuals seeking the translation of documents or interpreters at public meetings. To date, staff has not encountered a situation with any individual who did not speak English very well.

# Factor 3: The nature and importance of the program, activity, or service provided by the Johnson City MTPO to the community.

The Johnson City MTPO uses federal funds to plan transportation projects. While these projects are important, the Johnson City MTPO does not provide social programs, activities or services that would be directly benefit or provide basic needs for the public. However, the Johnson City MTPO seeks to include all segments of the population, including LEP individuals, in the transportation planning and decision making process. The steps that are taken for public outreach are detailed in the Public Participation Plan. This document is found on the website at <a href="https://www.jcmpo.org/ppp.html">www.jcmpo.org/ppp.html</a> and in the offices of the Johnson City MTPO.

#### Factor 4: The resources available to the Johnson City MTPO and costs.

The Johnson City MTPO ensures that efforts are made to include LEP individuals and provide them with the opportunity to be involved in the transportation planning process. These services are provided to the LEP individual free of charge. Resources that are currently provided for language assistance and their estimated cost to the Johnson City MTPO are:

- Telephone interpreter service is available, provided by Avaza Language Services, with a language identification guide available to MTPO staff to assist with identifying the LEP individual's native language. This guide is attached in the Appendix (Cost is 55 cents a minute);
- The Johnson City MTPO website is equipped with Google Translate to easily translate each webpage into a native language of choice (No Cost);
- The Title VI statement is printed in both English and Spanish, the language used by the majority of non-English speaking persons, on the poster and annual notice in the regional newspaper (\$80 for published notice in the Johnson City Press);
- The Title VI complaint procedures and complaint form is available in both English and Spanish (\$90 for these documents to be translated into Spanish).

Other services can be provided; however, the cost of such a service is indeterminable, as these services have not been requested in the past. After researching the basic pricing lists available on the internet, a best guess estimate of the cost is provided. These services may be provided upon request by an individual:

- Any document produced by the Johnson City MTPO can be translated into another language (estimated cost is \$50 for basic document, \$200 for 50-page document, and \$1,500 for the Long Range Transportation Plan).
- An interpreter can be made available for a public meeting, if requested (estimated cost is \$25 an hour).

#### **LEP Implementation**

The staff of the Johnson City MTPO will continue to offer the services mentioned above, along with periodic training for assisting LEP individuals. Each staff member maintains the language identification guide in their individual offices and staff vehicle, along with the procedures for contacting the telephone interpreter service. The website will continue to be maintained to provide Google Translate for easy translation of each webpage. The Title VI complaint documents will continue to be available in both English and Spanish. The services offered will be monitored and periodically reviewed during the update of the Title VI Program.
